Complaints Policy & Procedure Our aim: Jeffries & Partners Ltd are committed to providing a quality service for its customers. One of the ways in which we can continue to improve our service is by listening and responding to the views of our customers and in particular by responding positively to complaints, and by putting mistakes right.

Therefore we aim to ensure that:

- * making a complaint is as easy as possible;
- * we treat a complaint as a clear expression of dissatisfaction with our service which calls for an immediate response;
- * we deal with it promptly, politely and, when appropriate, confidentially;
- * we respond in the right way for example, with an explanation, or an apology where we have got things wrong, or information on any action taken etc;
- * we learn from complaints, use them to improve our service, and review annually our complaints policy and procedures.

Preamble

Definition: Jeffries & Partners Ltd defines a complaint as 'any expression of dissatisfaction (with Jeffries & Partners or with a member of staff) that relates to Jeffries & Partners and that requires a formal response'.

Purpose: The formal complaints procedure is intended to ensure that all complaints are handled fairly, consistently and wherever possible resolved to the complainant's satisfaction.

Jeffries & Partners Ltd responsibility will be to:

- * acknowledge the formal complaint in writing;
- * respond within a stated period of time;
- * deal reasonably and sensitively with the complaint;
- * take action where appropriate.

A complainant's responsibility is to:

- * bring their complaint, in writing, to Jeffries & Partners attention normally within 8 weeks of the issue arising;
- * raise concerns promptly and directly with a member of staff at Jeffries & Partners;
- * explain the problem as clearly and as fully as possible, including any action taken to date;
- * allow Jeffries & Partners a reasonable time to deal with the matter;
- * recognise that some circumstances may be beyond Jeffries & Partners control.

Responsibility for Action: All Staff, of Jeffries & Partners.

Confidentiality: Except in exceptional circumstances, every attempt will be made to ensure that both the complainant and Jeffries & Partners maintain confidentiality. However the circumstances giving rise to the complaint may be such that it may not be possible to maintain confidentiality (each complaint will be judged on its own merit). Should this be the case, the situation will be explained to the complainant.

Formal Complaints Procedure

Stage 1

In the first instance, if you are unable to resolve the issue informally, you should write to the member of staff who dealt with you, so that he or she has a chance to put things right. In your letter/email you should set out the details of your complaint, the consequences for you as a result, and the remedy you are seeking.

You can expect your complaint to be acknowledged within 3 working days of receipt. You should get a response and an explanation within 15 working days. If you are unsure which member of Jeffries & Partners staff to write to, your complaint should be sent to the Branch Manager at the office you are dealing with.

If the complaint is complex, a member of staff or the Branch Manager may escalate your complaint direct to Stage 2.

Stage 2

If you are not satisfied with the initial response to the complaint then you can write to the Operations Director, Jeffries & Partners Ltd, 1st Floor Orchard House, Furzhall Farm Fareham PO16 7JH and ask for your complaint and the response to be reviewed. You can expect the Operations Director to acknowledge your request within 3 working days of receipt and a response within 15 workings days.

Jeffries & Partners aim is to resolve all matters as quickly as possible. However, inevitably some issues will be more complex and therefore may require longer to be fully investigated. Consequently timescales given for handling and responding to complaints are indicative. If a matter requires more detailed investigation, you will receive an interim response describing what is being done to deal with the matter, and when a full reply can be expected and from whom.
